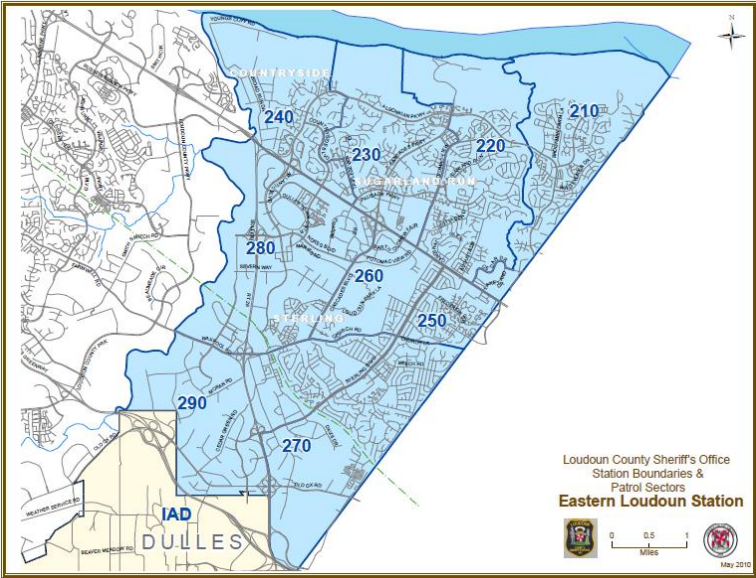

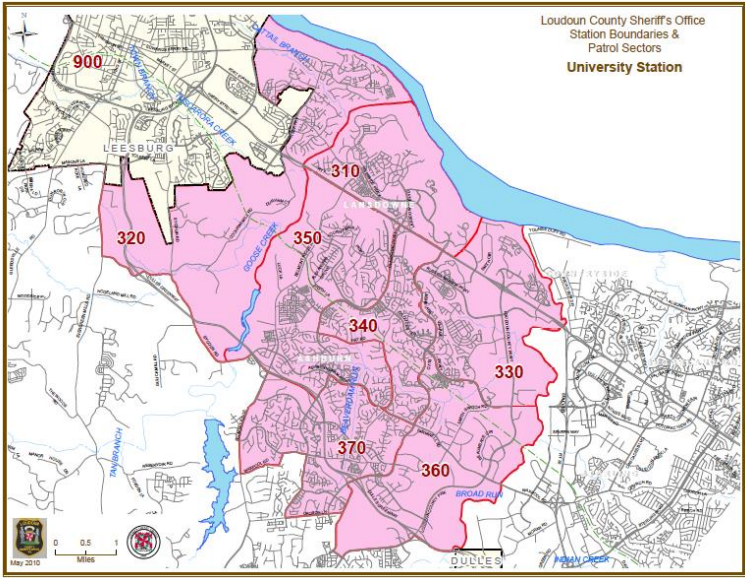


Station / Sector Maps

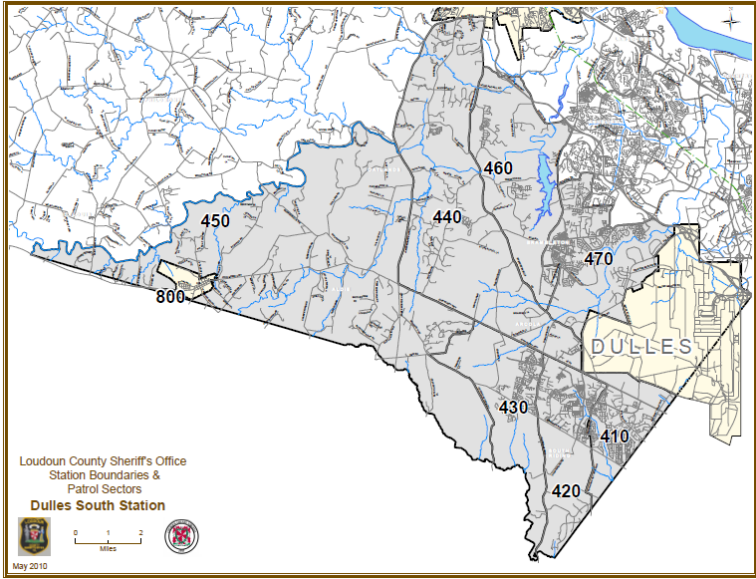
Eastern Loudoun Station: SECTOR 2
