02/24/2021	Sterling	<b>Government Scam:</b> The complainant reported that he received a call from a person claiming to be with Homeland Security. The caller reported that the complainant had been a victim of identity theft and that he needed to pay a penalty to fix the situation.

		The complainant purchased gift cards and provided the gift card information to the caller. This case remains under investigation. SO2100003209
02/26/2021	Round Hill	<b>Phishing Scam:</b> The complainant reported receiving an email from someone she thought was a friend asking for help in purchasing gift cards. The complainant, believing it was her friend, purchased the gift cards and sent the card numbers to the scammer. SO2100003197
02/26/2021	Round Hill	<b>Government Scam:</b> The complainant reported that he received a phone call from someone claiming to be with the FBI. The complainant was told to purchase gift cards and provide the scammer the card numbers. This case is still under investigation. SO2100003176
02/08/2021	Sterling	<b>Payroll Scam:</b> A representative for a business reported receiving an email request from an employee requesting a change to their direct deposit information. The routing number that was provided to the company was later found to be a Green Dot Bank number and that employee had made no such request. This case remains under investigation. SO2100003198

## If you are purchasing gift cards to pay for:

- Fixing a Computer
- Settling a Warrant for Your Arrest
- Settling a "Compromised Account" (Amazon, Apple, etc.)
- Bills, Taxes, Legal Fees, Bail, or a Missed Court Appearance
- **OR** you receive and email / text from "your boss" asking you to purchase gift cards with your own money **AND** to call or text a phone number with the gift card information.

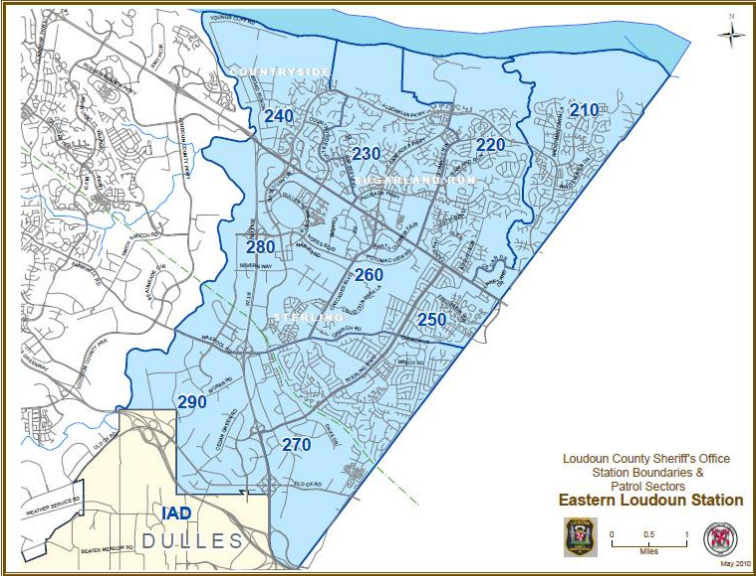

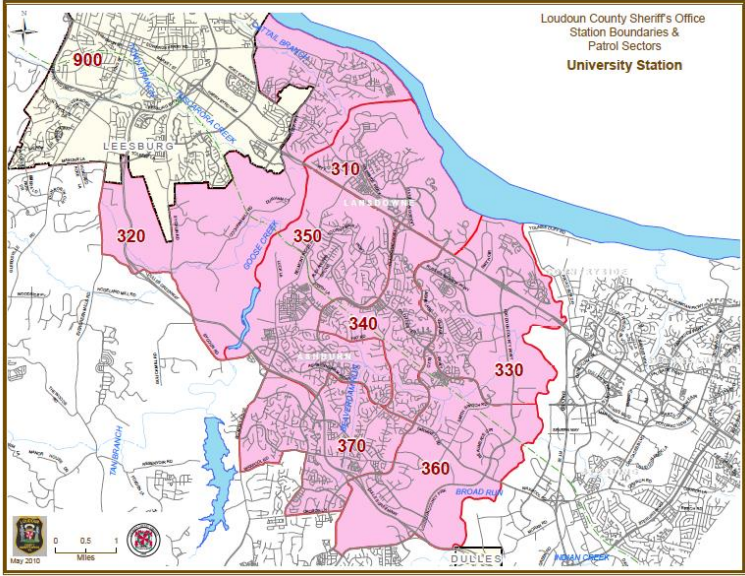


# Station / Sector Maps

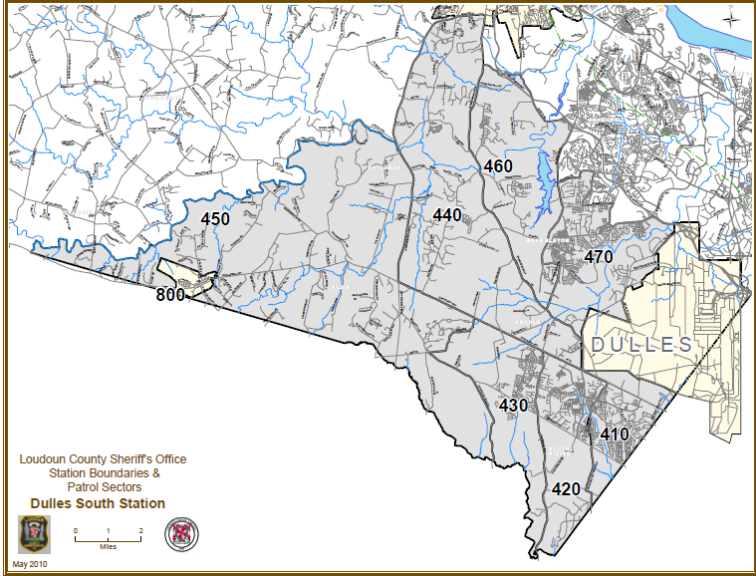
**Eastern Loudoun Station: SECTOR 2**
