



VDOT Public Information Meeting: Braddock Road & Old Lee Road Safety and Operational Improvements Study

VDOT has scheduled a public information meeting on potential safety and operational improvements at the intersection of Braddock Road and Old Lee Road, and the S-curve on Braddock Road. The meeting will be held on Thursday, February 13 in the lecture hall at Westfield High School (4700 Stonecroft Boulevard in Chantilly). You can stop by between 6:30 - 8:30 PM to view displays and learn more about the study. A presentation will begin at 7 PM and study staff will be available to answer your questions.

I requested that VDOT initiate a study of the Braddock Road corridor due the number of accidents and disabled truck incidents that occur on the S-curve, as well as the significant back-ups at the Old Lee intersection. I am pleased to see that the study has been completed and some recommendations are being presented for feedback from residents in the area. The concepts that are being studied include realignment of the S-curve and intersection enhancements such as turn lanes and intersection improvements. I look forward to continued cooperation with Fairfax and VDOT to address our transportation issues in the area.
