On Friday, December 17th at 12:00 p.m., please join me for a live virtual town hall on [Facebook](#) regarding COVID-19, vaccines, boosters, and the Omicron variant. Featured speakers/panelists are Dr. David Goodfriend, the Director of Loudoun County Health Department and Dr. John Farrell, the Chairman of the Loudoun County Health Commission and COVID Testing Task Force.

Health officials say the best way to prevent the newly identified [Omicron variant](#), or other COVID-19 variants from impacting Loudoun County, and to decrease COVID-19 cases is to follow proven prevention strategies:

- Everyone age 5 and older who has not already received a COVID-19 vaccination is encouraged to get vaccinated as soon as possible
- Wear a mask in indoor public settings
- Stay 6 feet away from people who do not live in your household
- Cover your coughs and sneezes
- Wash your hands frequently
- Stay home when sick
- Avoid contact with sick people

Know the [signs and symptoms of COVID-19](#) and remember to get tested if you're symptomatic, or if potentially exposed to COVID-19,
