## **Update - Full Closure of Library During Upgrade Period**

May 16, 2018

Further discussions regarding the extent of improvements to be completed at the Library have resulted in a decision from Library and County staff to fully close the facility during the upgrade period in order to ensure safety of Library staff and the general public. Previous plans

envisioned a partial closure during the upgrade. The construction time frame remains May 21 - June 1, 2018.

## **County Improvements to Purcellville Library (May 21 - June 1)**

I wanted to inform you of the below listed upgrades to the Purcellville Library scheduled to occur between May 21 & June 1, of 2018. During this time only the outdoor book return box and the main lobby area will remain open. The

remainder of the Library, to include Library programs and outside meetings, will be closed.

The following improvements are scheduled to occur:

- Replacement of pipe fittings in the adult area ceiling
- Replacement of second floor carpet
- Installation of new HVAC equipment
- Installation of new public restroom stalls
- Improvements to first floor staff workroom
- Re-pavement of public and staff parking lots
- Reorganization & other improvements to main area
