COMMUNITY PROJECTS

Last month, we celebrated two exciting milestones for Sterling. First, on February 8th, Loudoun County held a **groundbreaking for the Sterling Community Center**. - Widening the roadway,
- Adding a turn lane and improving drainage
- Curb ramp upgrades,
- New pavement markings, and
- Signage in compliance with the Americans with Disabilities Act requirements

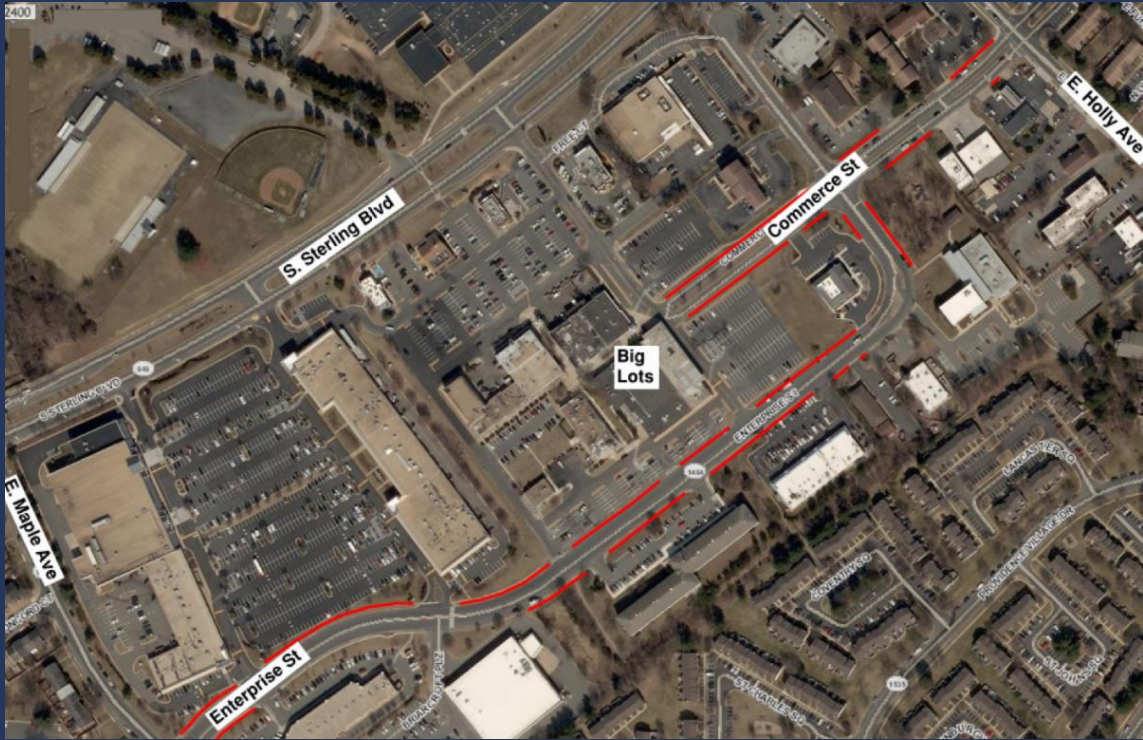
UPDATE: ON-STREET PARKING RESTRICTIONS on Enterprise St., Commerce St., and Shaw Rd.

Effective March 23, 2020, on-street parking will no longer be permitted on Enterprise Street, Commerce Street, and a portion of Shaw Road (*see maps below*) between 5:00 pm and 7:00 am, year-round.

Any vehicles parked during this time period will be subject to towing by the Loudoun County Sheriff's Office.

It is anticipated that on March 2, 2020 the installation of signage will commence. The installation is expected to take place Monday through Friday, between the hours of 7:00 AM and 3:30 PM until such time that all signage are installed and approved by VDOT.

THINGS TO KNOW



Real ID Act

Beginning October 1, 2020, residents will need to present a REAL ID compliant license, **OR** another acceptable form of identification for accessing Federal facilities and boarding commercial aircraft.

You will still need a passport for international travel. If you are **traveling domestically**, you will only need one valid form of identification: **EITHER** your REAL ID **OR** another acceptable alternative such as a passport, not both.
