Denise Corbo's Corner School Board Member, At-Large



I am very grateful for the educators, parents, staff and the community who are working together to support our children through nutrition, distance learning and community care. The school closure plan began with creating a system to feed every child across the County. Shortly after, Loudoun County Public Schools (LCPS) was able to organize and distribute Chromebooks and Hotspots to every 3rd through 12th grade student. Students between kindergarten and 2nd grade were mailed biweekly learning packets directly to their homes.

By emphasizing community outreach, LCPS was able to distribute over 316,000 meals serving students at bus stops and various schools throughout the community. The County has been using the school's 3D printers to create face shields for those who are in need. Loudoun Education Foundation has been a great partner and helped purchase 1,500 Hotspots to ensure all staff, students and families have the capability to engage

and collaborate with teachers. The School Board asked staff to make every effort to reach out to students and families personally to ensure all students have the opportunity, access and means to engage in communication and effective distance learning.

COVID-19 has brought state and local budget changes. Over the next two months, the School Board will need to cut \$73 million from our original budget request because of a revenue shortfall. I encourage the community to stay engaged and visit my [Facebook page](#) for any updates.

Finally, on behalf of the entire School Board, I want to thank the Board of Supervisors for their commitment to keeping our children and community safe as we move forward together.
