3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The recent Point in Time count revealed 22 unsheltered chronically homeless individuals, illustrating the continuing need for Permanent Supportive Housing beds. Loudoun County Department of Family Services (DFS) has been providing Permanent Supportive Housing (PSH) services to the chronically homeless since 2015. This program requests renewal for our program which provides rental assistance and supportive services. Our program currently supports twenty-three (23) chronically homeless persons: three families (including 5 children and 2 youth in the 18-24 range). The funding covers rental assistance for seven community-based units where participants sign a lease and rent is paid directly to a landlord. In addition, eight (8) facility-based units are located in a county owned building. Our program provides rental and follows a ‘Housing First’ model. DFS partners with its sister agency, Loudoun County Department of Mental Health, Substance Abuse and Developmental Services as well as local non-profits to offer support services to participants in the program. This renewing project partially funds a case manager who provides supportive services. These voluntary support services are offered to participants in order to maximize housing stability and address their individual needs. Services, such as job skill development, home maintenance, mediation, and housekeeping are designed to build independent living and tenancy skills and connect participants with community-based health care, treatment and employment services. Participants receive support to acquire and sign their own lease. Access to mainstream benefits, food stamps, Medicaid and View and programs offered through the Workforce Resource Center are also made available to participants. All client data is recorded in the Homeless Management Information System (HMIS) according to the most recent HMIS Standards issued by HUD/HHS. Eligible individuals are screened using the Vulnerability Assessment Tool as well as the VI-SPDAT assessment tool. The Eligibility Screening committee evaluates and ranks each applicant and those with the most significant needs and the longest history of homelessness are prioritized according to CPS-16-11 which highlights vulnerability.

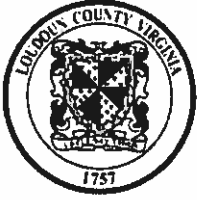


