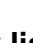

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The 2019 Point in Time count revealed 22 unsheltered chronically homeless individuals, illustrating the continuing need for Permanent Supportive Housing beds. Loudoun County Department of Family Services (DFS) has been providing Permanent Supportive Housing (PSH) services to the chronically homeless since 2015. DFS has been effectively providing PSH services as indicated by our performance measure which illustrates a retention rate of 100 percent. Through this grant, DFS currently serves four individuals who have been identified as experiencing chronic homelessness. Our program provides rental and follows a 'Housing First' model. DFS partners with its sister agency, Loudoun County Department of Mental Health, Substance Abuse and Developmental Services as well as local non-profits to offer support services to participants in the program. These voluntary support services are offered to participants in order to maximize housing stability and address their individual needs. Services, such as job skill development, home maintenance, mediation, and housekeeping are designed to build independent living and tenancy skills and connect participants with community-based health care, treatment and employment services. Participants receive support to acquire and sign their own lease. Access to mainstream benefits, food stamps, Medicaid and View and programs offered through the Workforce Resource Center are also made available to participants. All client data is recorded in the Homeless Management Information System (HMIS) according to the most recent HMIS Standards issued by HUD/HHS. Eligible individuals are screened using the Vulnerability Assessment Tool as well as the VI-SPDAT assessment tool. Individuals with the most severe service needs and longest documented history of homeless are prioritized according to the order established by HUD in CPD-16-011.
