



# EMERGENCY SERVICE PLAN

## 2021-2022



### LOUDOUN COUNTY TRANSIT BUS SERVICE

The Emergency Service Plan has two distinct parts to it. One is a delayed plan for the morning, and one is an early dismissal plan for the afternoon. The paragraphs below describe how each park & ride lot and each service is handled should the Emergency Service Plan be activated.

#### MORNING DELAYED SERVICE PLAN

**Commuter bus services that normally travel into Rosslyn, Crystal City, the Pentagon and Washington DC** will be directed to the West Falls Church Metro Station or the Wiehle-Reston East Metro Station.

**The Bustime App will not be available for this commuter bus schedule.**

- **LEESBURG** – Buses will depart to the West Falls Church Metro Station at 6:30am, 7:00am, 7:30am and 8:00am.
- **DULLES NORTH** – Buses will depart to the West Falls Church Metro Station at 6:45am, 7:16am, 7:46am and 8:16am.
- **DULLES SOUTH (STONE RIDGE II)** – This service is cancelled. Please see 88X information below for service to the Wiehle-Reston East Metro Station
- **EAST GATE** – This service is cancelled. Please see 88X information below for service to the Wiehle-Reston East Metro Station.
- **HARMONY** – This service is cancelled. Please see 931/932 information below for service to the Wiehle-Reston East Metro Station.
- **PURCELLVILLE** – This service is cancelled. Please see 931/932 information below for service to the Wiehle-Reston East Metro Station.

**ROUTE 87X - Dulles Town Center and Dulles Town Center Park & Ride Lot:** Service from the **Dulles Town Center** and the **Dulles Town Center park & ride lot** to the Wiehle-Reston East Metro Station will be reduced.

- **DULLES TOWN CENTER PARK & RIDE LOT** – Buses will depart at 6:00am, 6:40am, 7:30am, 8:12am and 8:54am.
- **DULLES TOWN CENTER** – Buses will depart at 7:24am, 8:06am and 8:48am.

**ROUTE 88X - StoneSprings Hospital, Stone Ridge I & East Gate:** Service will be to the Wiehle-Reston East Metro Station.

- **STONESPRINGS HOSPITAL** – Buses will depart at 5:50am, 6:56am and 8:18am.
- **STONE RIDGE I** – Buses will depart at 5:55am, 7:03am and 8:23am.
- **EAST GATE** – Buses will depart at 6:04am, 7:14am and 8:34am.

**ROUTE 901 - Potomac Falls Service:** All Potomac Falls service will be to the West Falls Church Metro Station.

- **BROAD RUN FARMS** – Buses will depart at 6:51am and 8:14am.
- **CASCADES** – Buses will depart at 7:00am and 8:23am.
- **OUR LADY OF HOPE** - Buses will depart at 7:04am and 8:27am.
- **LOWES ISLAND FRONT LOT** - Buses will depart at 7:08am and 8:33am.

**ROUTE 923 - Goose Creek Village/Broadlands:** Service to the Wiehle-Reston East Metro Station.

- **GOOSE CREEK** – Buses will depart at 5:57am, 6:48am, 7:39am and 8:30am.
- **BROADLANDS** – Buses will depart at 6:05am, 6:56am, 7:47am and 8:38am.

**ROUTE 925 - Loudoun Station/Dulles North Transit Center:** Service to the Wiehle-Reston East Metro Station.

- **LOUDOUN STATION** - Buses will depart at 6:07am, 6:55am, 7:45am, 8:35am and 9:25am.
- **DULLES NORTH TRANSIT CENTER** – Buses will depart at 8:43am and 9:33am.

**ROUTE 40 – Purcellville Connector:** Contact Virginia Regional Transit at 1-877-777-2708 for information.

**ROUTES 55/56/57 – Leesburg Routes:** Service will begin at the Loudoun County Government Center at 9:00am and then run on the regular schedule.

**ROUTE 62 – Ashburn Connector:** Service will begin at 9:00am at the Ashburn Village Giant and then run on the regular schedule.

**ROUTE 70 – Leesburg to/from Sterling:** Route 70 Eastbound will begin service at 9:00am at the Loudoun County Government Center, Route 70 Westbound will begin service at 9:00am at Potomac View/NVCC and then run on the regular schedule.

**ROUTE 72 – Wiehle Express:** Service will begin at the Wiehle-Reston East Metro Station at 8:12am and then run on the current schedule.

**ROUTE 80 – Sugarland Run:** Service will begin at 9:00am on Enterprise Street at East Maple Avenue and then run on the regular schedule.

**ROUTE 81 – Countryside Connector:** Service will begin at 8:55am at Winding Road and then run on the regular schedule.

**ROUTE 82 – Sterling Connector:** Service will begin at 9:15am at the William Waters House and then run on the regular schedule.

**ROUTE 84 – Atlantic Connector:** Service will begin at the Wiehle-Reston East Metro Station at 9:00am and then run on the regular schedule.

**ROUTE 931/932 – Purcellville:** Buses will depart at 5:45am, 7:15am, 8:45am. Buses will also serve the **Harmony** park and ride lot, departing at 6:00am, 7:30am, and 9:00am.

**ROUTE 985 – Sterling to the Wiehle-Reston East Metro Station:** Service will begin at 8:30am at Church Road Plaza and then run on the regular schedule.

**ROUTE 990 - Wiehle-Reston East Metro Station to Quantum Park & Oath: This service is cancelled.**

**SAFE-T-RIDE:** Service will begin at the Shenandoah Building bus shelter at 9:00am.

In the event of severe weather or other emergency situations Loudoun County may adjust the schedules for LC Transit Bus Service. This Emergency Service Plan details the schedule changes which could be activated. Any change to the level of service in the morning will be broadcast on local ABC, CBS, FOX & NBC networks as well as radio stations WINC (92.5 FM), WMAL (630 AM), and WTOP (103.5 FM).
