# LOUDOUN COUNTY TRANSIT BUS SERVICE



The Emergency Service Plan has two distinct parts to it, one is a delayed plan for the morning and one is an early dismissal plan for the afternoon. All runs in the morning and evening will operate on a load & go basis as directed by staff who will be on site. The following paragraphs describe how each park & ride lot and each service is handled should the Emergency Service Plan be pressed into use. **The Bustime App will not be available for this schedule.**

### MORNING DELAYED SERVICE PLAN

**THE FOLLOWING PARK AND RIDE LOTS WILL NOT HAVE ANY SERVICE WHEN THE DELAYED SERVICE PLAN IS IN EFFECT: PURCELLVILLE, ASHBURN NORTH, BRAMBLETON, STONE RIDGE I, AND BROAD RUN FARMS**

**Commuter bus services that normally travel into Rosslyn, Crystal City, the Pentagon and Washington DC will be directed to the West Falls Church Metro station and the fare will be \$1.50 with a SmarTrip® card or \$2.00 exact cash. The following lots will be closed when the Delayed Plan is in use: Purcellville, Ashburn North & Brambleton. In addition, East Gate and Loudoun Station will ONLY have service to Wiehle-Reston East Metro Station. If a park & ride lot is closed in the morning, it will not be serviced in the evening.**

**HARMONY** – Buses will depart **approximately** every 20 minutes from 6:30am-7:50am.

**LEESBURG** – Buses will depart **approximately** every 10 minutes from 6:30am-8:15am.

**DULLES NORTH** – Buses will depart **approximately** every 10 minutes from 6:30am-8:40am.

**DULLES SOUTH (STONE RIDGE II)** – Buses will depart **approximately** every 20 minutes from 6:30am-8:10am.

**PURCELLVILLE** – No Service

**ASHBURN NORTH** - No Service

**BRAMBLETON** – No Service

**EAST GATE** – No Service

**LOUDOUN STATION** – No Service

**ROUTE 901 - Potomac Falls Service: The Broad Run Farms park & ride lot will be closed.** All Potomac Falls service will be to the West Falls Church Metro station and the fare will be \$1.50 with a SmarTrip® card or \$2.00 exact cash.

**CASCADES** – Buses will depart **approximately** every 30 minutes from 6:45am-9:15am.

**OUR LADY OF HOPE** – Buses will depart **approximately** every 30 minutes from 6:50am-9:20am.

**LOWES ISLAND FRONT LOT** – Buses will depart **approximately** every 30 minutes from 6:55am-9:25am.

**BROAD RUN FARMS** – No Service

**ROUTES 921/923 - Harmony/Leesburg/Goose Creek Village/Broadlands Service to the Wiehle-Reston East Metro Station:** When the Delayed Plan is in operation, the services from **Harmony, Leesburg, Goose Creek Village & Broadlands** to the Wiehle-Reston East metro station will be combined. Several buses will operate from Harmony, Leesburg, Goose Creek Village and the Broadlands park & ride lots to the Wiehle-Reston East Metro station and the fare will be \$1.00 with a SmarTrip® card or \$1.50 exact cash.

**HARMONY** – Buses will depart **approximately** every 30 minutes from 6:30am-9:00am

**LEESBURG** - Buses will depart **approximately** every 30 minutes from 6:55am-9:25am

**GOOSE CREEK** – Buses will depart **approximately** every 30 minutes from 7:02am-9:32am

**BROADLANDS** – Buses will depart **approximately** every 30 minutes from 7:10am-9:40am

**ROUTE 925 - Loudoun Station:** Service to the Wiehle-Reston East metro station will be reduced. Buses will depart **approximately** every 30-40 minutes from 6:30am-9:15am.

**ROUTE 87X - Dulles Town Center and Dulles Town Center Park & Ride Lot:** Service from the **Dulles Town Center** and the **Dulles Town Center** park & ride lot to the Wiehle-Reston East Metro Station will be reduced.

**DULLES TOWN CENTER PARK & RIDE LOT** – Buses will depart **approximately** every 40-45 minutes from 6:30am-9:15am.

**DULLES TOWN CENTER** – Buses will depart **approximately** every 40-45 minutes from 7:00am-9:10am.

**ROUTE 88X - StoneSprings Hospital, Stone Ridge I & East Gate:** There will be no service from **StoneSprings** or **Stone Ridge I** to **Wiehle-Reston East Metro Station**. Service from **East Gate** park & ride lot to the **Wiehle-Reston East Metro Station** will be reduced.

**EAST GATE** – Buses will depart **approximately** every 30-40 minutes from 6:30am-9:15am.

**STONESPRINGS HOSPITAL** – No Service

**STONE RIDGE I** – No Service

**ROUTE 990/993 - Wiehle-Reston East Metro Station to Quantum Park & Oath:** Rt 990-994 buses will begin running with the Rt. 993 trip at **8:00 am** from Wiehle-Reston East Metro Station and then run on the regular schedule.

**ROUTE 931/932 – Purcellville:** Service to the Wiehle-Reston East Metro Station: **CANCELLED** – No Service

**ROUTE 72 – Wiehle Express:** Service will begin at the Wiehle-Reston East Metro Station at 8:05am and then run on the regular schedule.

**ROUTE 84 – Atlantic Connector:** Service will begin at the Wiehle-Reston East Metro Station at 8:57am and then run on the regular schedule.

**ROUTE 985 – Sterling to the Wiehle-Reston East Metro Station:** Service will begin at 8:30am at Church Road Plaza and then run on the regular schedule.

**ROUTE 70 – Leesburg to-from Sterling:** Route 70 Eastbound will begin service at 9:00am at the Loudoun County Government Center, Route 70 Westbound will begin service at 9:00am at Potomac View/NVCC.

**ROUTES 55/56/57 – Leesburg Routes:** Service will begin at the Loudoun County Government Center at 9:00am and then run on the regular schedule.

**SAFE-T-RIDE:** Service will begin at the Shenandoah Building bus shelter at 9:00am.

**ROUTE 62 – Ashburn Connector:** Service will begin at 9:00am at the Ashburn Village Giant.

**ROUTE 80 – Sugarland Run:** Service will begin at 9:00am on Enterprise Street at East Maple Avenue.

**ROUTE 81 – Countryside Connector:** Service will begin at 8:55am at Winding Road.

**ROUTE 82 – Sterling Connector:** Service will begin at 9:00am at the William Waters House.

**ROUTE 40 – Purcellville Connector:** Contact Virginia Regional Transit at 1-877-777-2708 for information.

In the event of severe weather or other emergency situations Loudoun County may adjust the schedules for LC Transit Commuter Bus Service. This Emergency Service Plan details the schedule changes which could be activated. Any change to the level of service in the morning will be broadcast on local ABC, CBS, FOX & NBC networks as well as radio stations WINC (92.5 FM), WMAL (630 AM), and WTOG (103.5 FM). In addition, the LC Alert system will communicate that the Delayed Service Plan is activated and a recorded message will be available at 703-771-5665 by 4:30am. #### Emergency Service Plan Information

The Emergency Service Plan has two distinct parts to it, one is a delayed plan for the morning and one is an early dismissal plan for the afternoon. All runs in the morning and evening will operate on a load & go basis as directed by staff who will be on site. The following paragraphs describe how each park & ride lot and each service is handled should the Emergency Service Plan be pressed into use. **The Bustime App will not be available for this schedule.**

#### AFTERNOON EARLY DISMISSAL BUS PLAN

**Commuter bus services that normally pick up from Rosslyn, Crystal City, the Pentagon and Washington DC** will only pick up from the north bus bays of the West Falls Church Metro station (Orange Line) and the fare will be \$1.50 with a SmarTrip® card or \$2.00 exact cash. The buses will depart from the West Falls Church Metro station **approximately** every 15 – 20 minutes, between 2:00pm and 5:55pm. Staff will be on site to assist with the operation. At Dulles North a shuttle will be available to transport passengers to their final destination – Leesburg, Harmony, Purcellville, Brambleton, Stone Ridge II, East Gate, Loudoun Station & Ashburn North.

**ROUTE 902 - Potomac Falls Service:** All Potomac Falls service will be directed to the north bus bays of the West Falls Church Metro station. Buses will depart from West Falls Church approximately every 30-35 minutes between 2:30pm and 5:40pm.

**ROUTES 922/924 - Broadlands/Goose Creek Village/Leesburg/Harmony/Purcellville Service from the Wiehle-Reston East Metro Station:** There will be several buses to Broadlands, Goose Creek Village, Leesburg & Harmony lots from the South bus bay P at the Wiehle-Reston East Metro station. The buses will depart **approximately** every 30 minutes between 2:30pm and 5:20pm. **Routes 927/928 will be cancelled.**

**ROUTE 926 - Loudoun Station from the Wiehle-Reston East Metro Station:** Buses will depart **approximately** every 25 minutes from 2:00pm-5:45pm.  
**Routes 927/928 will not operate!**

**ROUTE 992 – Service from Quantum Park/OATH/Raytheon/Pacific Blvd to the Wiehle-Reston East Metro Station:** Buses will depart approximately every 20-30 minutes between 2:00pm-5:00pm.  
**ROUTE 994 - Service from the Loudoun County Government Center to the Wiehle-Reston East Metro Station:** Bus will depart the Loudoun County Government Center at 3:30pm.

**ROUTE 87X - Dulles Town Center and Dulles Town Center Park & Ride lot from the Wiehle-Reston East Metro Station:** Buses will depart **approximately** every 40-45 minutes between 2:30pm-5:30pm.

**ROUTE 88X - StoneSprings, Stone Ridge I Park & Ride lot and East Gate Park & Ride lot from the Wiehle-Reston East Metro Station:** Buses will depart **approximately** every 30-40 minutes between 2:30pm-6:00pm

**ROUTE 931/932 – Purcellville Park & Ride lot from the Wiehle-Reston East Metro Station:** Buses will depart **approximately** every 30 minutes from 2:00pm-6:00pm.
