The Loudoun County Office of Elections is excited to announce our first “I Voted” Sticker Design Contest. The winning design will be used during the 2022 General Election. Stickers will be given to voters at Early Voting and Election Day polling locations and sent to voters who vote by mail.

How to Enter: Participants must agree to the official contest rules and submit their design by completing an “I Voted” Sticker Design Contest entry form. The contest will open on March 10, 2022 and will close at 11:59 p.m. on April 22, 2022. Participants must submit designs by [filling out this form](#). (If this link does not open on the first try, please right click and select open hyperlink)

Eligibility: The contest is open to all Loudoun County residents. You may enter as an individual or a group. Multiple entries are permitted.

Sponsors: The Loudoun County Office of Elections and Electoral Board.

Design requirements: Two inch (2”) diameter circle with design containing no more than 4 colors. The phrase “I voted” or a variation of the theme must be included in the design.

All designs must be submitted electronically and to ensure print quality all designs must be submitted as vector files, or as high-resolution JPG. Contest rules & entrants’ certification: By submitting an entry, each entrant acknowledges that their entry: a) is their original work; b) does not contain references to any candidates or political parties or advocate for or against any issue; c) does not violate or infringe upon the copyrights, trademarks rights of privacy, publicity or other rights of any person or entity; d) does not and will not violate any applicable law, statute, ordinance, rule or regulation; e) does not feature the likeness of a private individual without that individual’s written permission for its use; and f) does not trigger any reporting or royalty obligation to any third party. The Loudoun County Office of Elections and the Electoral Board reserve the right to disqualify any entry that they determine, in their sole judgment and discretion, (i) contains material or images that are obscene, defamatory, or inappropriate for a general audience that may include minors; or (ii) otherwise violates the contest rules. Further, by submitting an entry, each entrant acknowledges and agrees that in the event their design is selected as a winning entry, the Loudoun County Office of Elections and



Electoral Board have the exclusive and irrevocable right to use the winning design for the official "I Voted" sticker.

Judging Criteria: The Office of Elections and the Electoral Board will review all entries for conformance to the contest rules and evaluate all conforming entries on the following criteria: a) overall aesthetics or eye-catching ability; b) clarity, strength, and effectiveness of design; and c) uniqueness of the design in relation to Loudoun County. Eight finalists will be selected to advance to an online vote by the public to determine three winning entries. Online voting will open on May 19, 2022, and close at 11:59 p.m. on May 30, 2022. The Office of Elections will review and verify the winners. Verification is the process of staff confirming the winner with the information provided on the submission form. Announcement of the 3 winning designs is anticipated to occur by June 2, 2022.

Contest Winners: The Office of Elections will notify the winners via email and phone using the contact information listed on the contest entry form. If a winner cannot be verified by the Office, the design with the next highest votes will become a potential winner, subject to verification. Once the winner has been verified the Office of Elections will announce the winning design.

Additional Terms and Conditions: By entering the contest, each contestant agrees to comply with and be bound by the Official Rules and the decisions of the Loudoun County Office of Elections and Electoral Board, which are binding and final in all matters relating to this contest.
