## Community Health

The Community Health division is focused on maintaining and improving the health of all Loudoun County residents through communicable disease surveillance and prevention, direct patient care and nutrition services.

Services offered may have age or income restrictions and include:

- ✓ **Dental care & school screenings for children**
- ✓ **Family planning**
- ✓ **HIV evaluation and case management**
- ✓ **Immunizations**
- ✓ **Maternity care**
- ✓ **Sexually transmitted infection evaluation**
- ✓ **Tuberculosis testing and treatment**
- ✓ **Women, Infants & Children (WIC) nutrition services**

Community Health also investigates rabies exposures as well as reportable diseases, such as Lyme disease, measles, pertussis and other infections, to help prevent the spread of disease in Loudoun County.

## Environmental Health

The Environmental Health division maintains and improves the health of all County residents through disease prevention, surveillance efforts and community health promotion. Many of these services support State and County regulations.



The division is responsible for:

- ✓ **Well and septic system permitting and evaluation**
- ✓ **Permitting and inspecting restaurants and other food establishments**
- ✓ **Permitting temporary food vendors**
- ✓ **Hotel, motel and bed & breakfast permitting and inspection**
- ✓ **Public swimming pool permitting and inspection**
- ✓ **Death certificates**
- ✓ **Investigating public health nuisance complaints**
- ✓ **Rabies and Lyme disease surveillance and education**

## Emergency Preparedness



The Health Department has a critical role in responding to any potential public health emergency in Loudoun County, such as a flu pandemic, an outbreak of disease or foodborne illness, or a bioterrorist attack. Department planners develop and exercise emergency preparedness and response plans for such events.

The Health Department has established a Medical Reserve Corps (MRC) of both medical and non-medical volunteers. They assist with routine Health Department activities, such as back to school vaccinations, and help keep our community safe in an emergency, by helping staff mass vaccination and medication dispensing sites.
