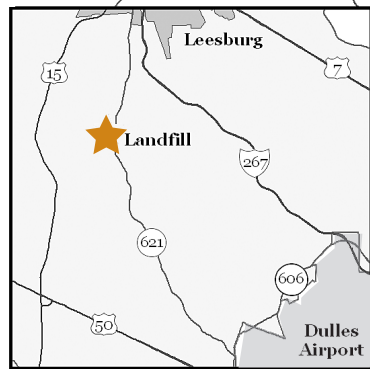
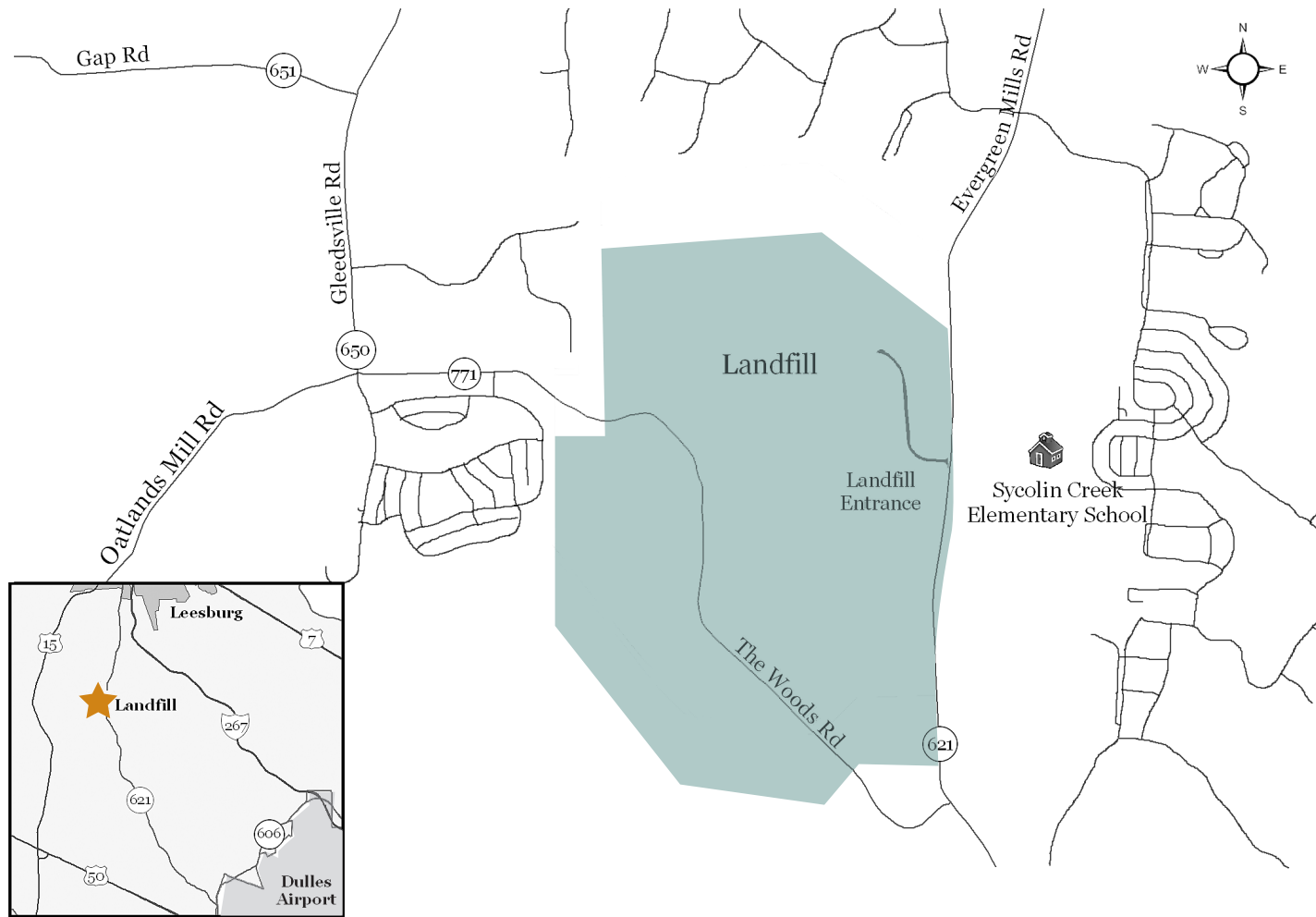


LOUDOUN COUNTY LANDFILL LOCATION MAP



Directions to Landfill

From Eastern Loudoun: Take Rt. 7 W. to Rt. 7/Rt. 15 to Warrenton/Winchester (Leesburg Bypass). Exit on Rt. 15 S. to Warrenton. Left on Evergreen Mill Road (Rt. 621). Landfill is 4.5 miles.

From Western Loudoun: Take Rt. 7 E. towards Leesburg. Exit Rt. 15 S. to Warrenton. Turn left at stop sign onto Clubhouse Drive. Turn right at traffic light onto King Street. Make a left on Evergreen Mill Road (Rt. 621). Landfill is 4.5 miles.

From Southern Loudoun: Take Rt. 50 (John Mosby Highway) to Rt. 606 (Loudoun County Parkway). Travel North on Rt. 606 0.8 miles. Turn left onto Evergreen Mills Road. Landfill is about 8.1 miles.

From Northern Loudoun: Take Rt. 15 S. toward Leesburg. Exit Rt. 15 S. to Warrenton. Turn left at Evergreen Mill Road (Rt. 621). Landfill is 4.5 miles.

Loudoun County Landfill Waste Disposal

*Closed New Year's Day, Memorial Day, Independence Day, Labor Day,
Thanksgiving Day, Christmas Eve (call first), and Christmas Day.*

The Loudoun County Solid Waste Management facility is a one-stop disposal and recycling option for Loudoun Residents and Businesses. The facility includes a state-of-the-art 300-acre landfill for municipal solid waste and construction waste, with an estimated life expectancy of 60 years. The facility has both fee and non-fee collection centers for recyclable materials including automotive fluids, auto batteries, bottles and cans, mixed paper, cardboard, scrap metal, and yard debris. The facility is owned and operated by Loudoun County and is supported by user fees. The facility also operates a free mulch depot subject to mulch availability.

WASTE ACCEPTED

- **Household Waste**
- **Commercial Waste**
- **Demolition Waste**
- **Institutional Solid Waste**
- **Construction Waste** including clean dirt, concrete, road pavement, brick and block
- **Propane Tanks** from 1 lb. to 100 lbs.
- **Scrap Metal** including appliances, grills, bed frames, bicycles, and others
- **Tires** from cars, trucks and tractors
- **Vegetative Waste** under 3' diameter x 8' length
- **Large Animal Carcasses**

WASTE ACCEPTED WITH CONDITIONS

- **Storage/Fuel Tanks or Drums** must be empty, cleaned and cut in half.
- **Lawn Mowers/Small engines** – Remove oil and fuel
- **Refrigerators/Freezers** – Remove food/contents

WASTE NOT ACCEPTED

- **Asbestos**
- **Ammunition**
- **Radioactive Waste**
- **Free Liquid Waste**
- **Compressed Gas Cylinder**
(i.e., oxygen, acetylene, welding gases)
- **Hazardous Waste** (see www.loudoun.gov/hhw)
- **Waste originating from outside Loudoun County**
- **Regulated Medical Waste**
- **Petroleum Contaminated Soil**

RECYCLE FIRST — NO FEE

If you need to recycle, you should **first** go to the **RECYCLING CENTER**. The following materials must be placed in their proper recycling container:



- Used Motor Oil
- Used Antifreeze
- Automobile Batteries and Lead-Acid Batteries
- Bottles and Cans
- Newspaper, Magazines, Catalogs, Phone Books, Office Paper and Junk Mail
- Cardboard and Paperboard

IMPORTANT DISPOSAL INFO

- **Only one vehicle on scale at a time.**
- **Make all declarations and tell the scalehouse operator** what you have to throw away (i.e., regular household garbage, tires, construction materials, propane tanks, appliances).
- **Follow the directions and signs** to the proper location for disposal.
- After disposal, use the **wheel wash** to remove the mud and dirt from your vehicle tires.
- **Return to the scalehouse and pay** the disposal fee unless you are a Saturday **FastTrash** customer.
- **Cash and Visa and MasterCard credit/debit cards accepted. No checks.** Credit accounts are available to businesses with prior approval.
- **Items dropped off cannot be picked up or removed** after they are disposed.

Declarations, Additional Charges & Fees

Customers must declare all items to the scalehouse operator before disposal. Additional fees are charged for each of the following items:

- Propane Tanks.....\$ 2
- Refrigerant Containing Appliances\$25
- Car Tire without Rim\$2.50
- Truck Tire without Rim\$4
- Small Tractor Tire without Rim\$25
- Large Tractor Tire without Rim\$35
- Tire with Rim.....\$26
- Improper Disposal of Appliances, Wet Cell Batteries, Tires per unit.....\$35

FastTrash

\$6 per vehicle

(Saturdays only, maximum ten 33 gallon bags)

- Fast Trash is a Saturday only, \$6 cash flat-fee program for household waste.
- Customers will be directed to Convenience Area and then will exit the Landfill bypassing the scale house.
- **PAYMENT IS CASH ONLY – NO CHECKS AND NO CREDIT/ DEBIT CARDS.**
